Volume Editors

Ala Alwan

Ala Alwan is Regional Director Emeritus, World Health Organization (WHO). He was Professor of Global Health and Principal Investigator of the Disease Control Priorities Country Translation Project at London School of Hygiene & Tropical Medicine; Affiliate Professor, Global Health, University of Washington; and Honorary Professor at Imperial College London and University of Oxford. At WHO, Dr. Alwan was Assistant Director-General for Noncommunicable Diseases (NCDs) and Mental Health, Representative of the WHO Director-General for Emergencies and Health Action in Crises, and Regional Director for the WHO Eastern Mediterranean Region. Dr. Alwan coordinated the development of the Global Strategy for the Prevention and Control of NCDs and led the work of WHO and the United Nations (UN) in preparing for the first UN General Assembly High-Level Meeting on NCDs, which resulted in the adoption of the UN Political Declaration on NCDs in September 2011. In Iraq, he was Professor of Medicine and Dean of Faculty of Medicine, Minister of Health and Minister of Education (2003–05), and again Minister of Health and Environment (2018–19).

Mizan Kiros Mirutse

Mizan Kiros Mirutse is a global health expert, holding a PhD in global health from the University of Bergen, Norway, and currently a postdoctoral researcher at Bergen Centre for Ethics and Priority Setting. With over 12 years of professional experience in the Ethiopian health sector, Dr. Mizan has held pivotal roles, including Director for Resource Mobilization, Director General of the Ethiopia Health Insurance Agency, Senior Health Financing Advisor to the Minister of Health, and National COVID-19 Response Coordinator. David A. Watkins

David A. Watkins is an associate professor in the Division of General Internal Medicine and in the Department of Global Health at the University of Washington. He currently leads the University of Washington site for the Disease Control Priorities Project and is affiliated with the Implementation Science Program in the Department of Global Health. Additionally, he is the Co-Director of the Learning for Action in Policy Implementation and Health Systems Initiative. He studies health system reform and policy challenges, with a particular emphasis on universal health coverage and the growing burden of noncommunicable diseases in low-income countries. His team works in three thematic areas: (1) population and economic modeling to support policy analysis, (2) integrated health care delivery, and (3) use of evidence in policy formulation. In addition to his scholarly work, Dr. Watkins teaches on global noncommunicable diseases and quantitative research methods and practices as a hospitalist at Harborview Medical Center.

Kalipso Chalkidou

Kalipso Chalkidou is the Director of the Department of Health Financing and Economics at the World Health Organization headquarters. Before that she founded and ran the Department of Health Finance at the Global Fund to Fight AIDS, Tuberculosis and Malaria. She is a Visiting Professor of Global Health at the School of Public Health, Imperial College London. Before moving to Geneva she was Director of Global Health Policy and a Senior Fellow at the Center for Global Development.

Her past work has concentrated on helping governments build technical and institutional capacity for using evidence to inform health policy as they move toward universal health coverage. She is interested in how local information, local expertise, and local institutions can drive scientific and legitimate health care resource

allocation decisions. She has been involved in the Chinese rural health reforms and in national health reform projects in Colombia, Ghana, India, South Africa, Türkiye, and the Middle East, working with the Inter-American Development Bank; Pan American Health Organization; UK Foreign, Commonwealth & Development Office; and World Bank as well as national governments.

Victoria Y. Fan

Victoria Y. Fan is a senior economist in health financing at the World Bank. She previously served at the Center for Global Development over 2011–14 and 2022–24. From 2014 to 2024, she was on the faculty at the University of Hawaii, including tenured associate professor and interim director of the Center on Aging. At the university, she founded the Pacific Health Analytics Collaborative, a lab with more than 120 employees and an annual operating budget of \$10 million, which conducted policy research on social determinants of health and mental health. During the COVID-19 pandemic, she established and chaired the Hawaii Pandemic Applied Modeling workgroup advising state leaders while serving as executive director of Hawaii CARES, the state's integrated call center and managed care network for mental health and substance use. She has more than 200 publications, including 70 in peer-reviewed journals. She holds a doctorate in health systems from Harvard and a bachelor's in mechanical engineering from the Massachusetts Institute of Technology. She was born and raised in Hawaii.

Muhammad Ali Pate
