#### Subject 18/22 Matters of information

#### New Programme Auditor

Anna-Karin Hurtig from University of Umeå, Sweden has been appointed as the new external Programme Auditor (ekstern fagfelle).

#### **Program evaluation 2023**

The Master Program in Global Health is scheduled to carry out its next 5-year program evaluation in 2023.

Since the Master in Global Health has been selected in the ongoing NOKUT audit, and the work of obtaining documentation for NOKUT could be helpful in the work with program evaluations. The Faculty therefore considers it appropriate the study programme starts the evaluation work in the autumn of 2022. The deadline for submitting the program evaluation is 1 April 2023.

Based on the completed the Study Quality Committee at the Faculty will provide a recommendation on whether the programme should be reaccredited. Final decision is made by the Faculty Board.

The Programme Committee is responsible for carrying out the evaluation but should set up a working group to carry out the assignment. Both students and representatives from working life and society who are relevant to the Master Programme should contribute. (Encl. 2 - in Norwegian).

### Subject 19/22 The NOKUT (The National Agency for Quality in Education) audit 2022: Master's program in global health

The Master Program in Global Health has been selected by NOKUT for an audit. The commission is to document how we follow up the systematic quality work at the Faculty and in the Master Programme in accordance with two paragraphs in:

#### The Student Supervision Regulations:

§ 4-1 (2): The quality work shall be anchored in the institution's boards and leadership at all levels. Through the quality work, the institution shall contribute to promoting a quality culture among staff and students.

§ 4-1 (3): The institution shall have procedures for systematically checking that all study programmes satisfy the requirements of the regulations on quality assurance and quality development in higher education and vocational education § 3-1 to § 3-3 and chapter 2 of these regulations.
