

"In European societies work-life balance implies the presence of a variety of social actors, being the most relevant ones the family, the State and the market. Mediterranean and Scandinavian countries have traditionally displayed a different combination of these factors; in Mediterranean countries the family holds more relevance while in Scandinavian countries the State assumes the responsibility of providing formal care, services and money transfers for the families. However, the current situation of global financial crisis has introduced into the political agenda a discussion about the ways care should be provided and the actors that should be involved.

This workshop will be focus on work-life balance strategies on Mediterranean and Scandinavian countries, considering childcare policies, services and resources and analyzing the commodification of care-work and the emergence of new ways of understanding care activities"
