29.08.2024 (not yet opened)	Research project	ERC Advanced Grant (link) ERC Advanced Grants are for established, leading principal investigators pursuing groundbreaking, high-risk/high-gain projects. Find out more about ERC-AdG on this website.
23.10.2024	Coordination and Support	COST (link) "Participants are invited to submit COST Action proposals contributing to the scientific, technological, economic, cultural or societal knowledge advancement and development of Europe. [...] A COST Action is an interdisciplinary research network that brings researchers and innovators together to investigate a topic of their choice for 4 years. COST Actions are typically made up of researchers from academia, SMEs, public institutions and other relevant organisations or interested parties."
20.11.2024 (not yet opened)	Research and Innovation Action	Security topic 2 - Post-quantum cryptography transition (link) "The advent of large-scale quantum computers will compromise much of modern cryptography, which is instrumental in ensuring cybersecurity and privacy of the digital transition. Any cryptographic primitive based on the integer factorization and/or the discrete logarithm problems will be vulnerable to large-scale quantum-powered attacks. The digital data/products/systems that derive their security ultimately from the abovementioned primitives will be compromised and must be upgraded - including their replacement when needed- to quantum-resistant cryptography. The massive scale of this foreseen upgrade shows that preparations are needed today in order to widely implement the relevant mitigations in the future. Many companies and governments cannot afford to have their protected communications/data decrypted in the future, even if that future still seems distant. There is a need to advance swiftly in the transition to quantum-resistant cryptography. Post-quantum resistant cryptographic algorithms should be deployable in a dynamic manner in order to quickly react to new quantum computer developments. Recommendations for post-quantum cryptography have already been published, but have to be maintained up-to-date, Proposals received under this topic should contribute to developing coordinated European recommendations for the transition to post-quantum cryptography across the EU. The identification and analysis of potential regulatory aspects and barriers for the developed technologies/solutions is encouraged, where relevant."
21.01.2025 (not yet opened)	Research and Innovation Action	Energy topic 2 - Critical technologies for the future ocean energy farms (link) "Projects are expected to address at least one of the following areas: ... 3. Artificial Intelligence (AI) in ocean energy technology development. Develop or apply advanced simulation of ocean energy systems. Use of big data with analysis of data streams, application of big data methods and machine learning, including artificial intelligence, or digital twin models for the design, installation, operation and decommissioning of ocean energy devices."

15.04.2024	Coordination and Support	UTFORSK (link) “The Norwegian Directorate for Higher Education and Skills announces up to NOK 90 million in funding to educational partnerships between higher education institutions in Norway and Brazil, Canada, China, India, Japan, South Africa, South Korea, and the United States of America (USA).”
19.04.2024	Innovation	UiB ide (link) “UiB idé gives employees and students the opportunity to apply for support to test and develop good innovation ideas.”
26.04.2024	Coordination and support	UiB Global Challenges UiB has issued a call within its strategic area “Global Challenges”. Funding covers meeting, seminar and travel costs needed to develop cross-disciplinary research activities. Proposals need to include concrete plans for research collaboration and future grant applications. Employees at Postdoc, researcher, Assoc./Professor level with UiB as their main employer can apply. You can apply in two different categories: 1) international research collaboration to promote external funding applications, and 2) invitation of guest researchers. Please have a close look at the eligibility criteria and proposal requirements on the SPIRE website. If you plan to apply for guest researcher support, then please consult the department’s information site about our guest researcher routines and register your guest(s) prior to submitting your SPIRE proposal. When submitting your SPIRE proposal, please indicate if you have obtained approval from the department to invite this guest in case you are awarded SPIRE funds. Proposals need to follow the template (see website) and have to be sent to Stefanie Meyer by 9 May 2024.
04.06.2024	Research	NordForsk Arctic Sustainability (link) “The Nordic countries have teamed up with Canada and the USA to launch a NordForsk call on the sustainable development of the Arctic. The call is two-stage, and the deadline for pre-proposals is 4 June 2024. [...] The main aim of the call is to support research collaboration among participating countries in the Arctic region to bring forward new knowledge on how to ensure the sustainable development of the Arctic. The objective is to jointly fund interdisciplinary research projects of the highest international quality, with potential for impact and societal relevance, and with clear added value from multilateral collaboration. The call has no thematic priorities, but three keywords can inspire applicants when developing their research ideas into proposals: Security, Natural Resources, and/or Societal Changes.”
10.06.2024	Coordination and support	Young CAS (link) The Young CAS Grant “is the funding opportunity offered to early career scholars below the age of 40. Recipients of a Young CAS Grant receive funding and support for their research project and gain valuable experience in organising multiple workshops and a two-month research stay at the Centre.”
01.06.2024 01.12.2024	Internship	Erasmus+ internship (link) Funding scheme for students/PhD students who would like to receive non-academic training in the form of an internship (2-12 months duration).

The Grants have two goals – to contribute to a more equal Europe, both socially and economically – and to strengthen the relations between Iceland, Liechtenstein and Norway, and the 15 Beneficiary States in Europe. [...] The Grants are composed of two funding schemes – the EEA Grants and the Norway Grants. The main difference between the two lies in where the funding comes from and which countries receive the funding.”
